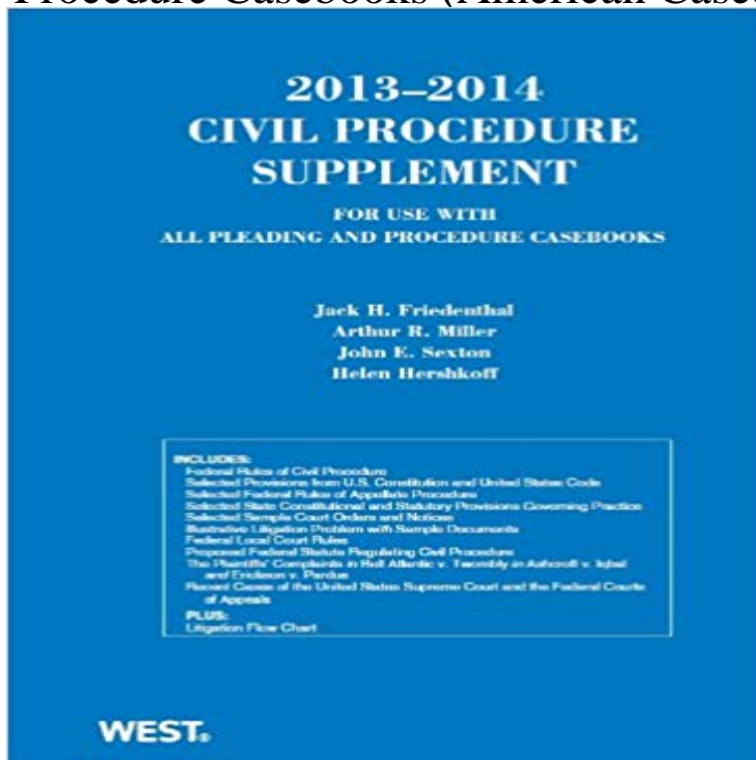


Civil Procedure 2013-2014 Supplement for use with all Pleading and Procedure Casebooks (American Casebook Series)
