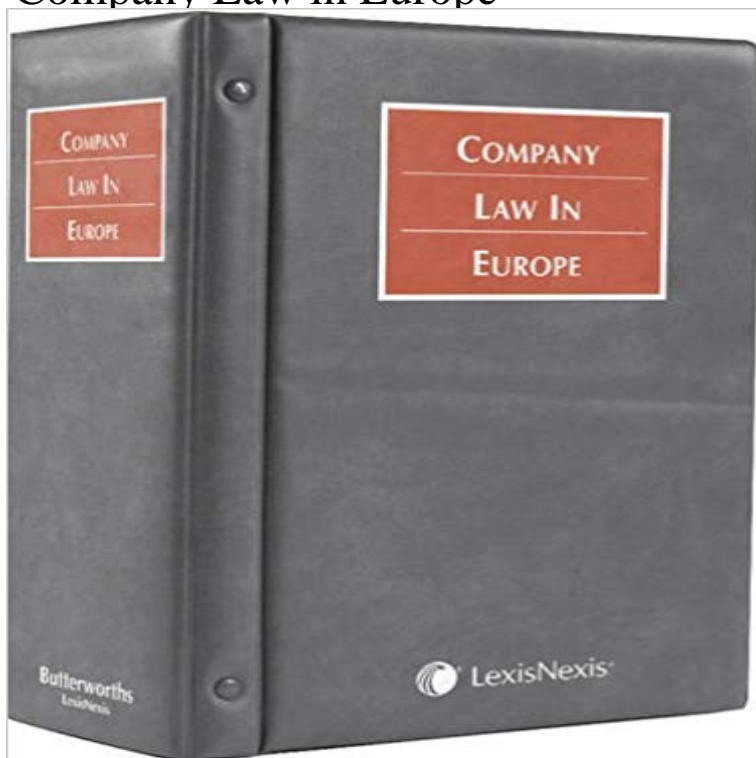


## Company Law in Europe
