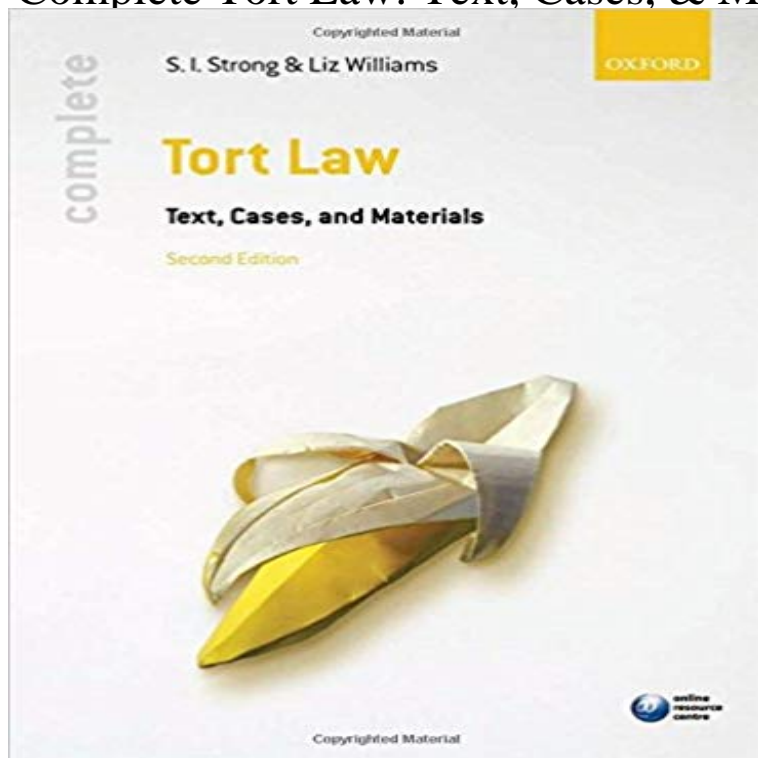


Complete Tort Law: Text, Cases, & Materials
