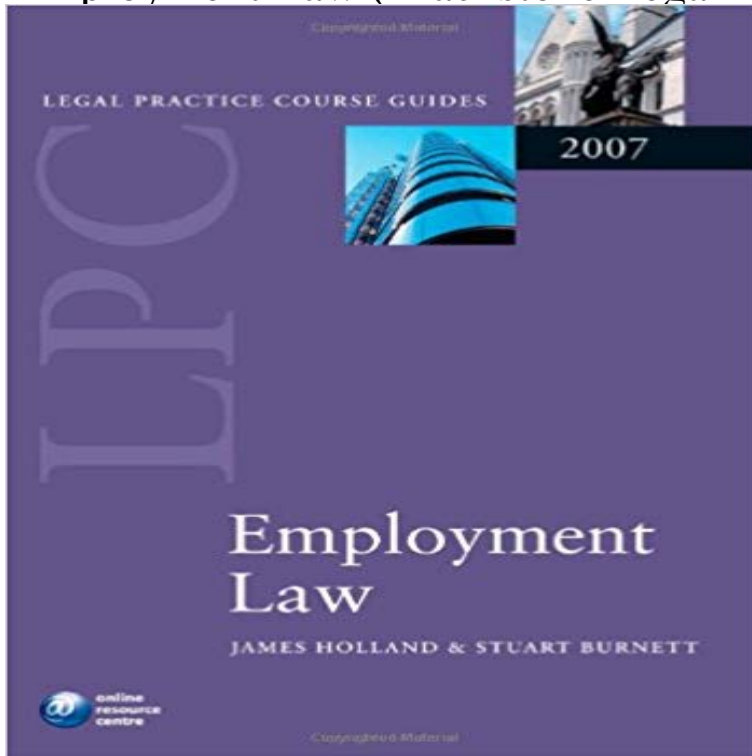


Employment Law (Blackstone Legal Practice Course Guide)
