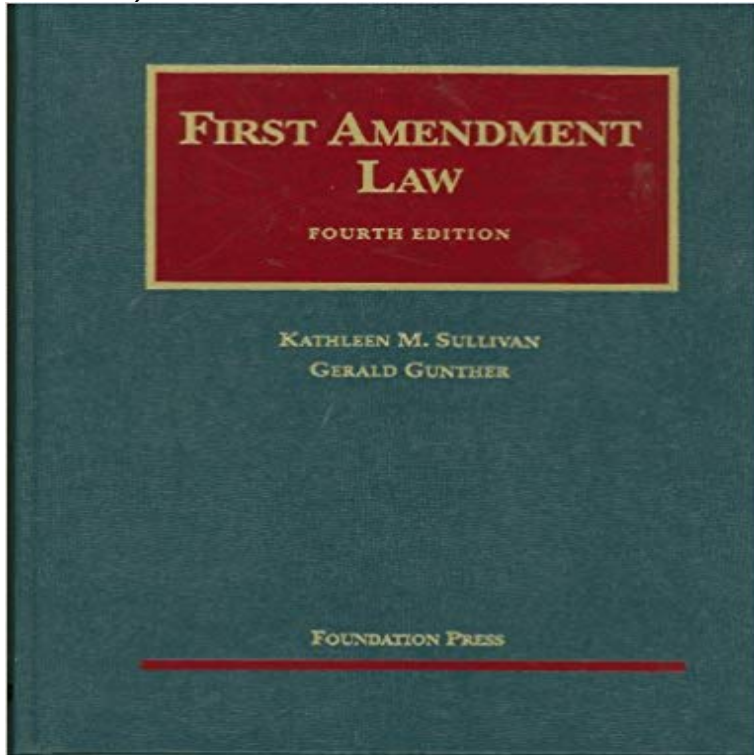


## First Amendment Law, 4th (University Casebooks) (University Casebook Series)
