The Dissenting Report of Mr. Greeley With Reference to the Revision of the Trademark Law is an 1898 report submitted to the United States Congress by Arthur P. Greeley, in response to a majority report submitted by two other members of a panel reviewing patent and trademark laws. The panel was unanimous in its report on the patent laws; Congress chose to follow the recommendations in Greeleys dissenting report in crafting a new trademark law.
