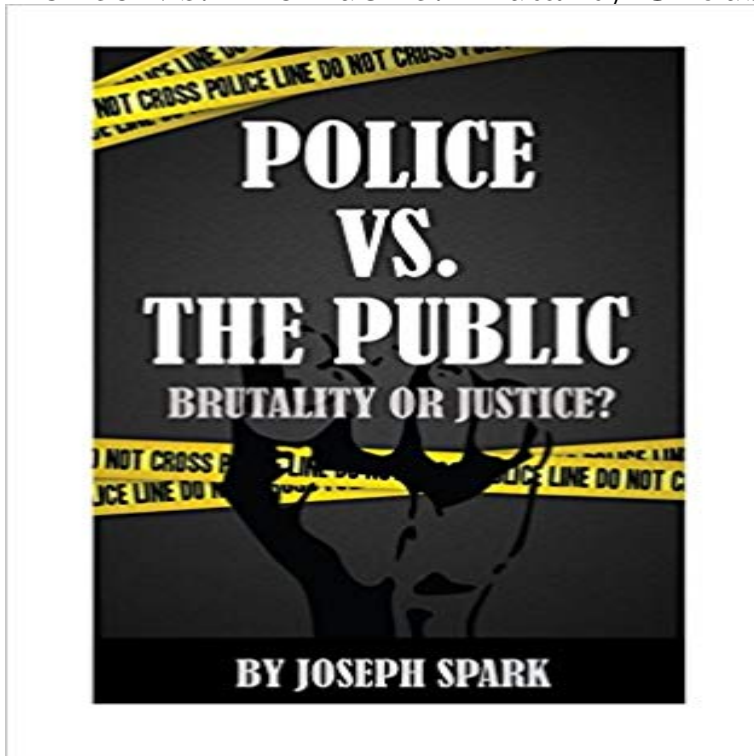


## Police Vs. The Public: Brutality Or Justice?
