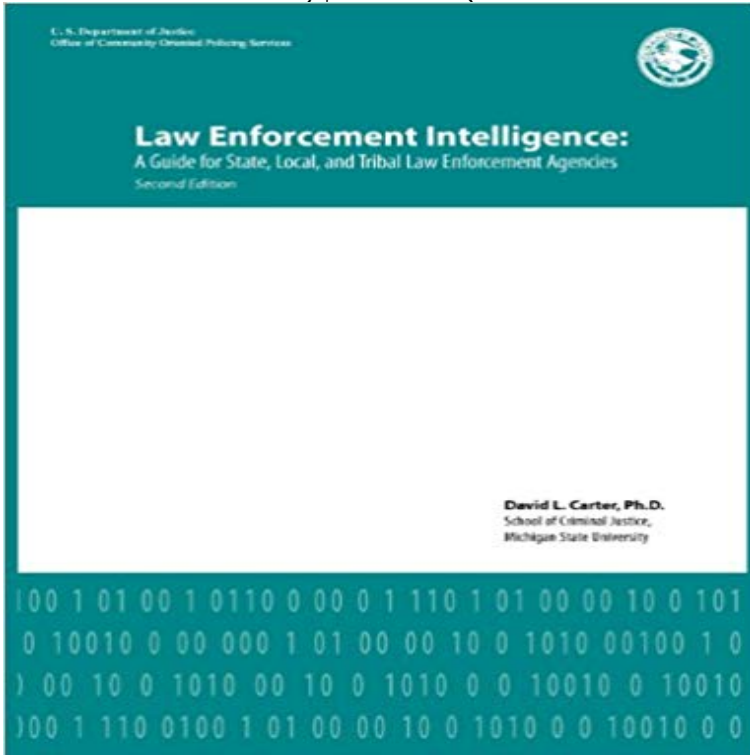


Law Enforcement Intelligence: A Guide for State, Local, and Tribal Law Enforcement Agencies (Second Edition)
