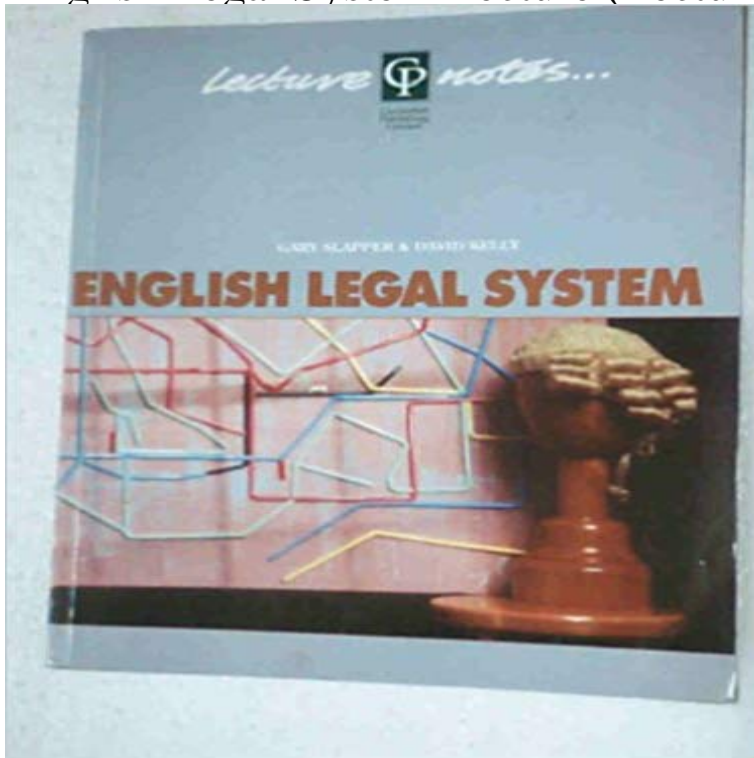


English Legal System Lecture (Lecture Notes)
