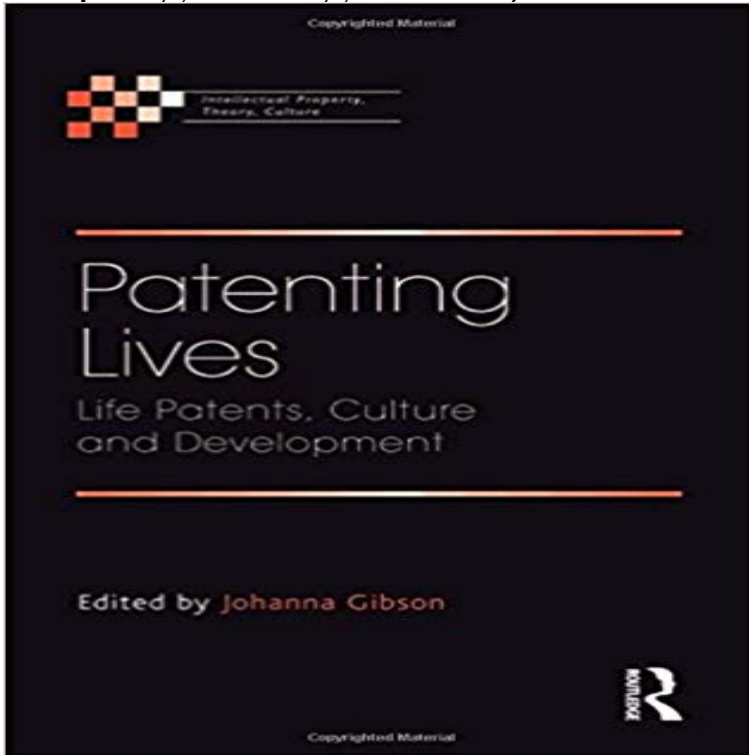


Patenting Lives: Life Patents, Culture and Development (Intellectual Property, Theory, Culture)
