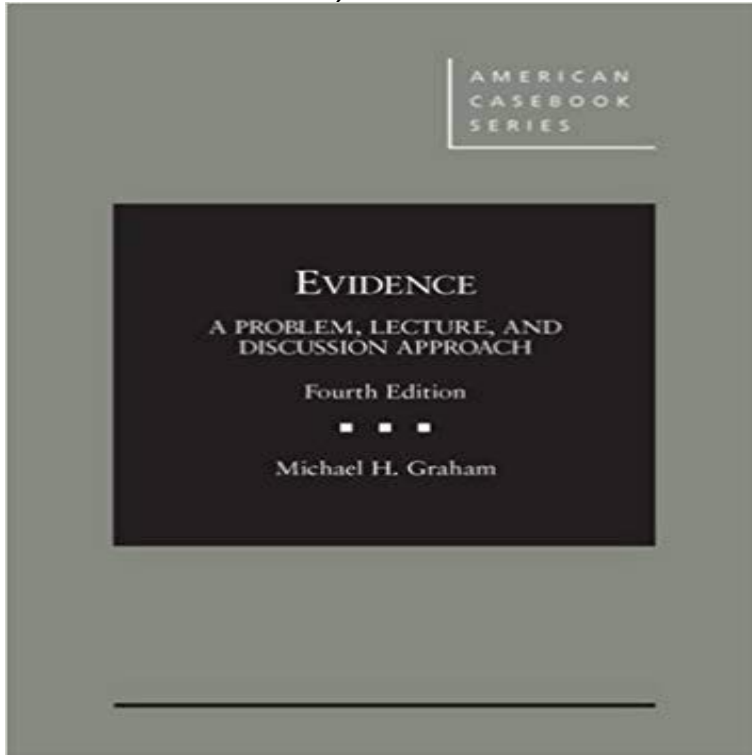


## Evidence: Problem, Lecture, and Discussion Approach (American Casebook Series)
