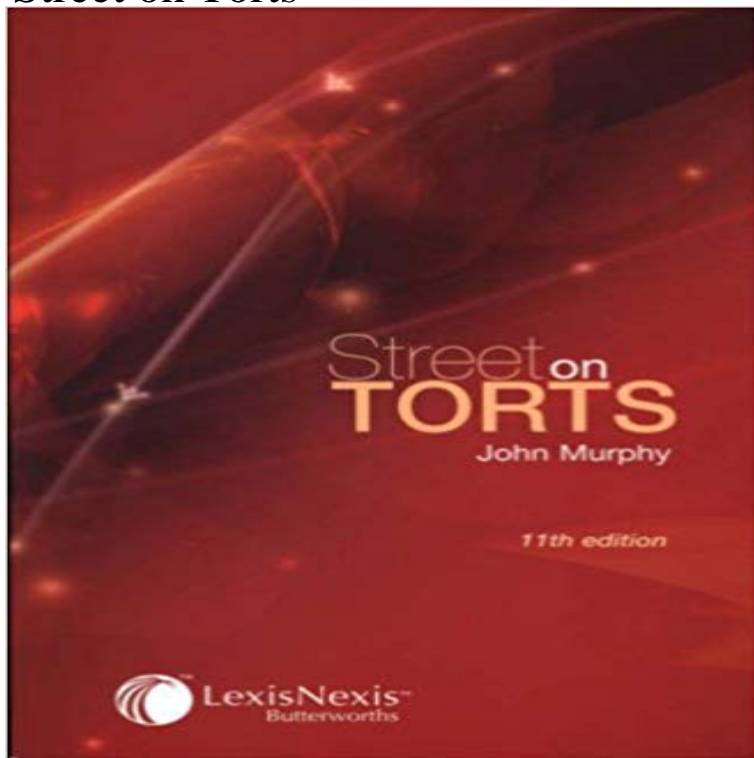


## Street on Torts
